INVESTMENT POOL YIELD:

The yield during this quarter is .608% before fees and .522% after fees.

MARKET VALUE:

The market value of the portfolio as of March 31, 2022, is at 97.20% of cost. The market values are down from the last Quarterly Report. Market values were obtained from SunGard Financial Systems and Bloomberg.

REVERSE REPURCHASE AGREEMENTS:

The pool has no reverse repurchase agreements.

WEIGHTED AVERAGE MATURITY:

The weighted average days to maturity is 666 days.

Excluding SCEIP investments, the weighted average days to maturity is 658 days.

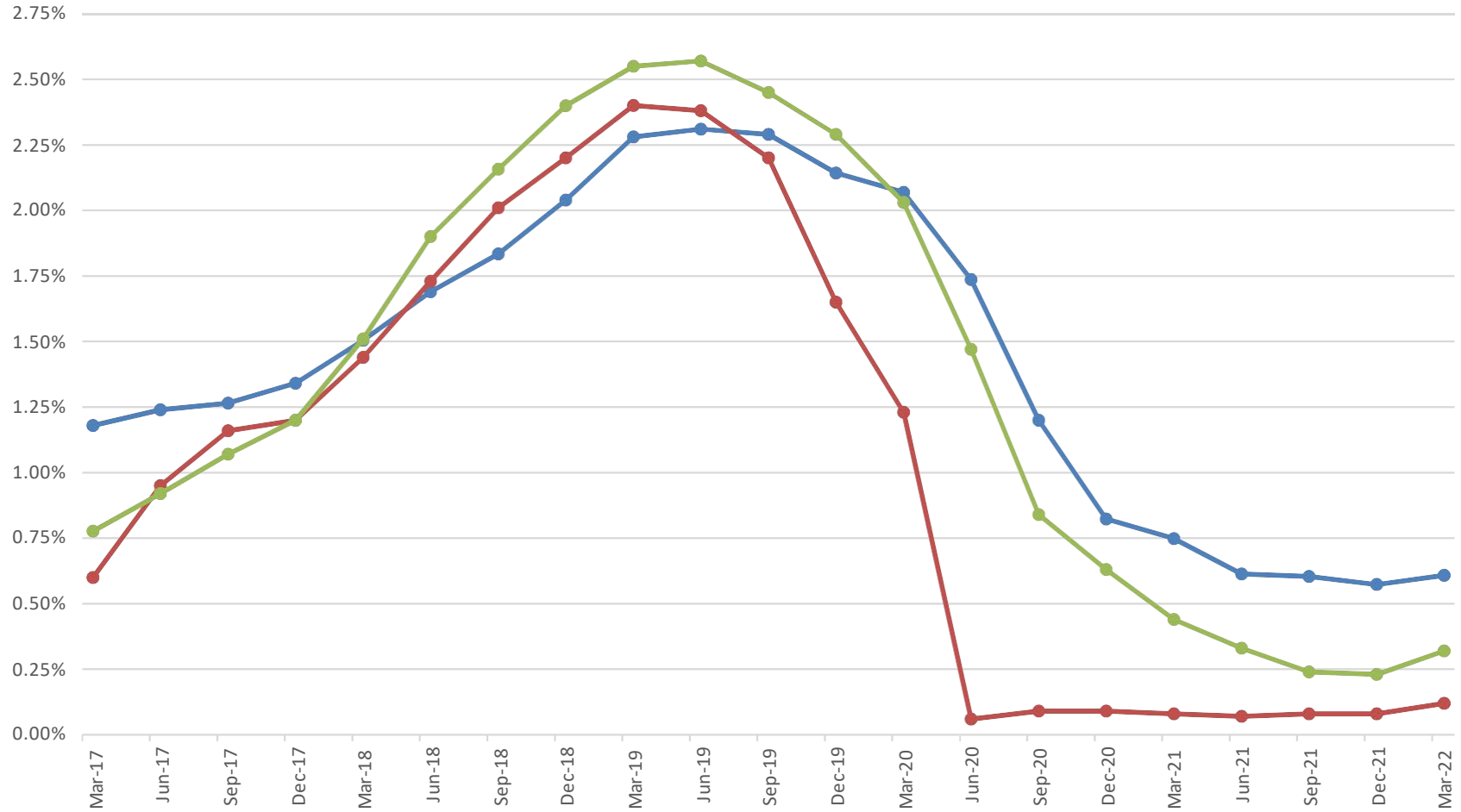

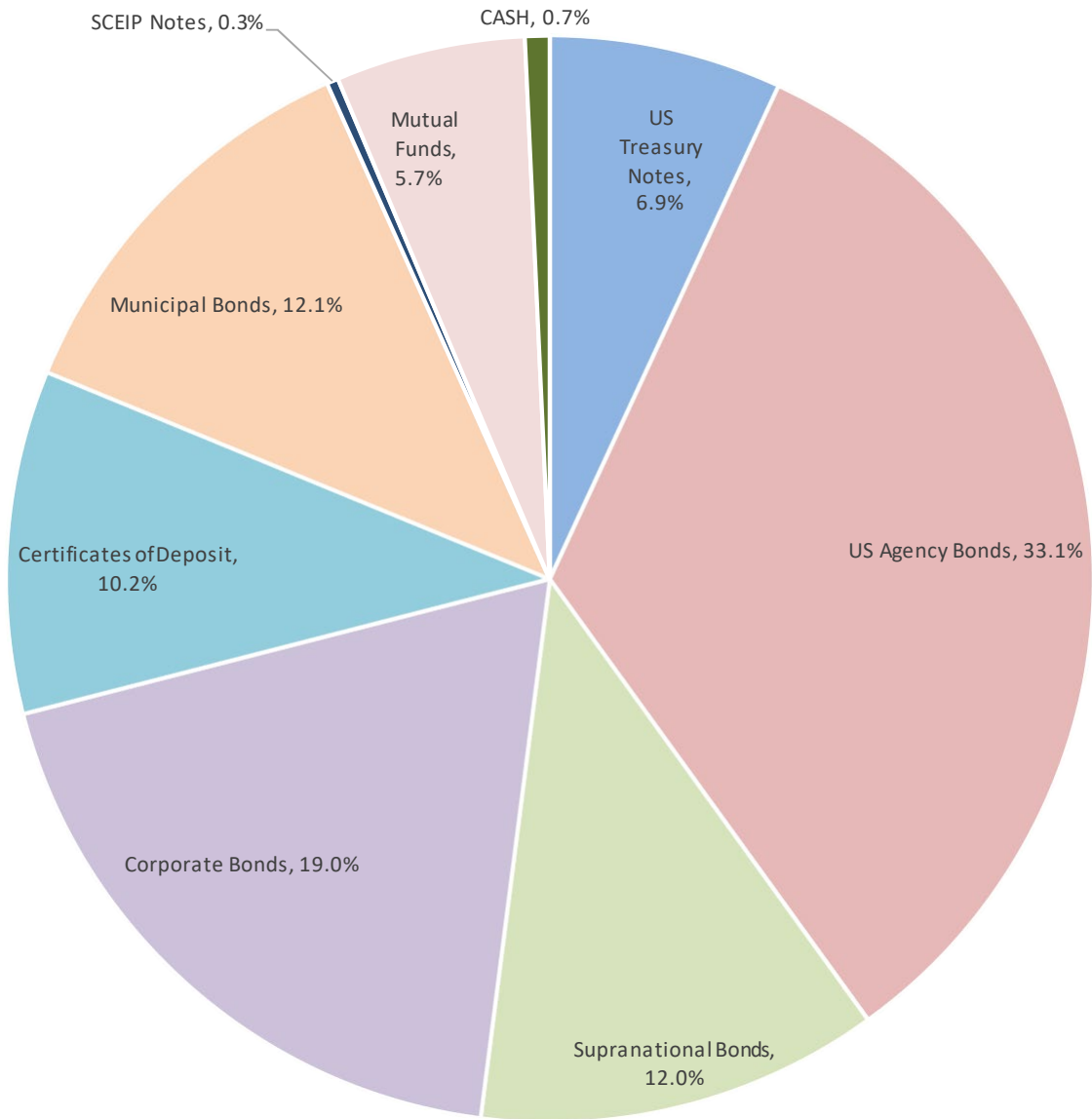
Sonoma County Treasurer Invest Pool Quarterly Yield Comparison March 31, 2022



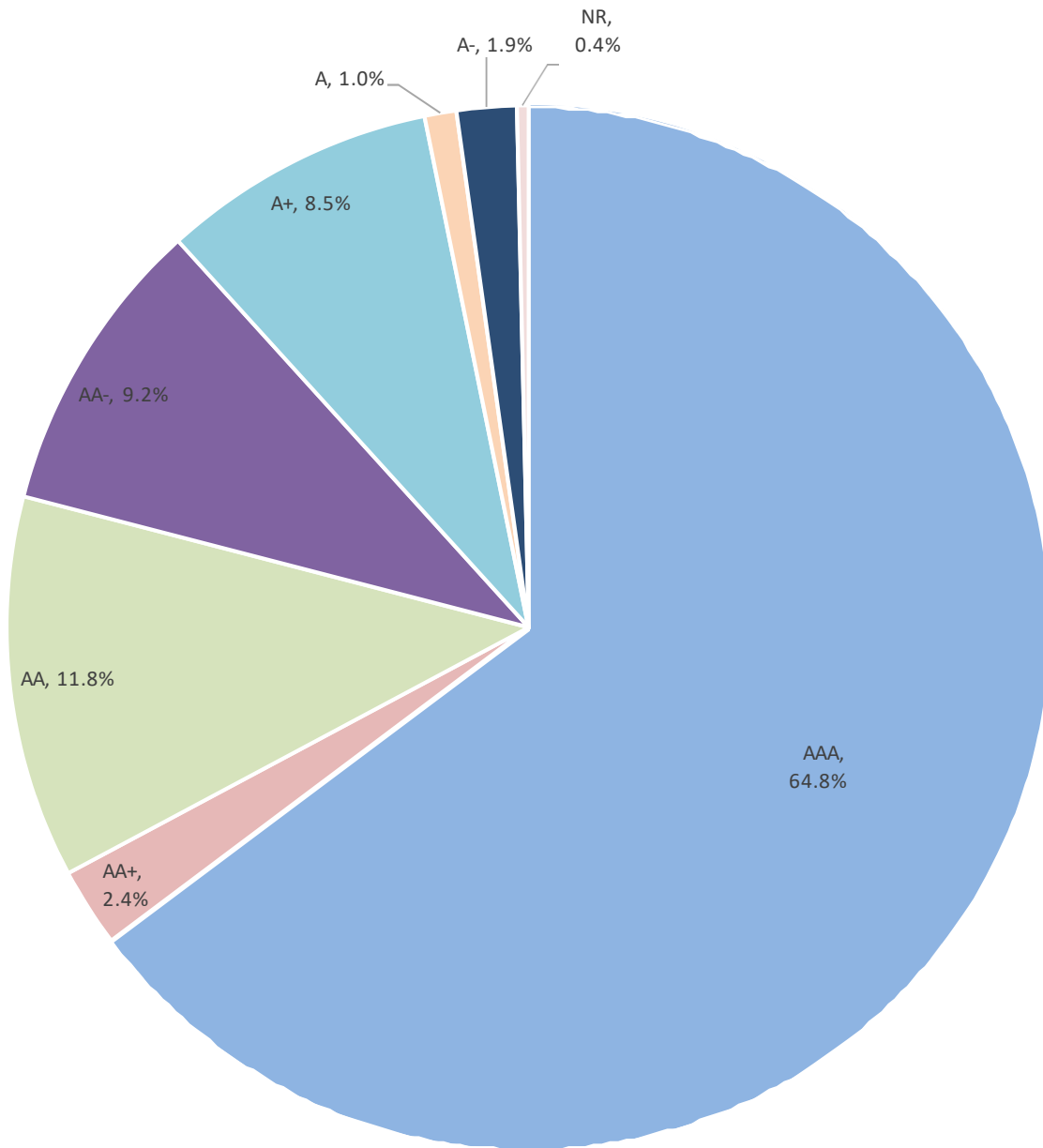
