INVESTMENT POOL YIELD:

The yield during this quarter is .573% before fees and .478% after fees.

MARKET VALUE:

The market value of the portfolio as of December 31, 2021, is at 99.46% of cost. The market values are down from the last Quarterly Report. Market values were obtained from SunGard Financial Systems and Bloomberg.

REVERSE REPURCHASE AGREEMENTS:

The pool has no reverse repurchase agreements.

WEIGHTED AVERAGE MATURITY:

The weighted average days to maturity is 711 days.

Excluding SCEIP investments, the weighted average days to maturity is 702 days.

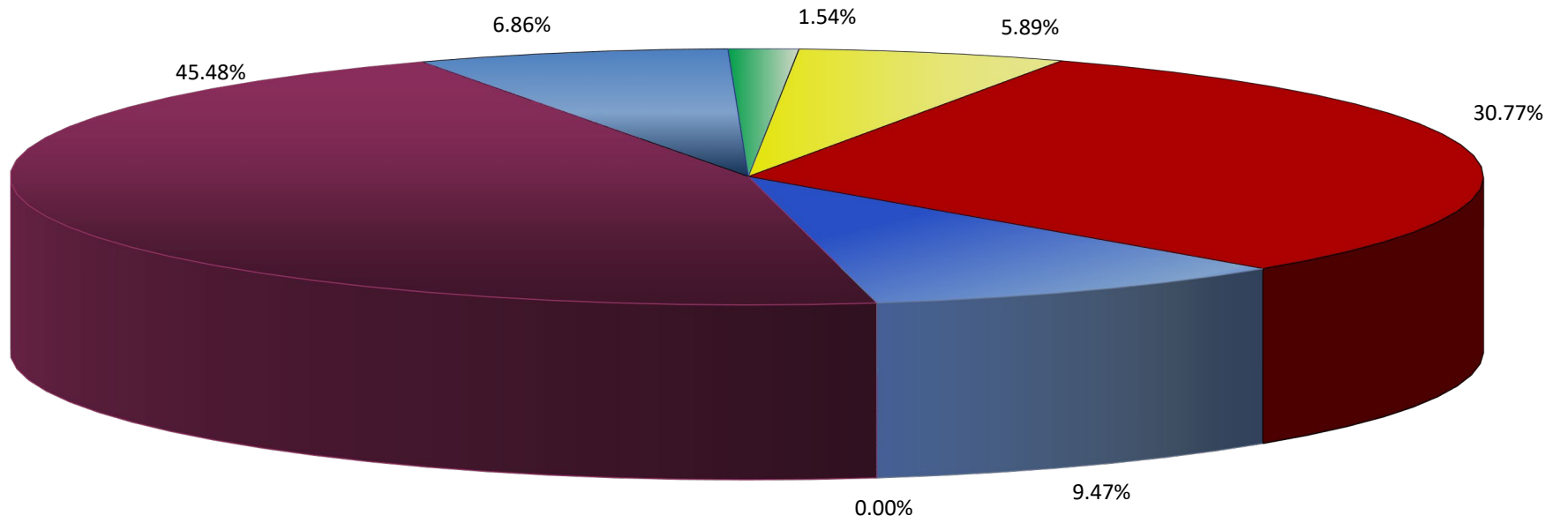

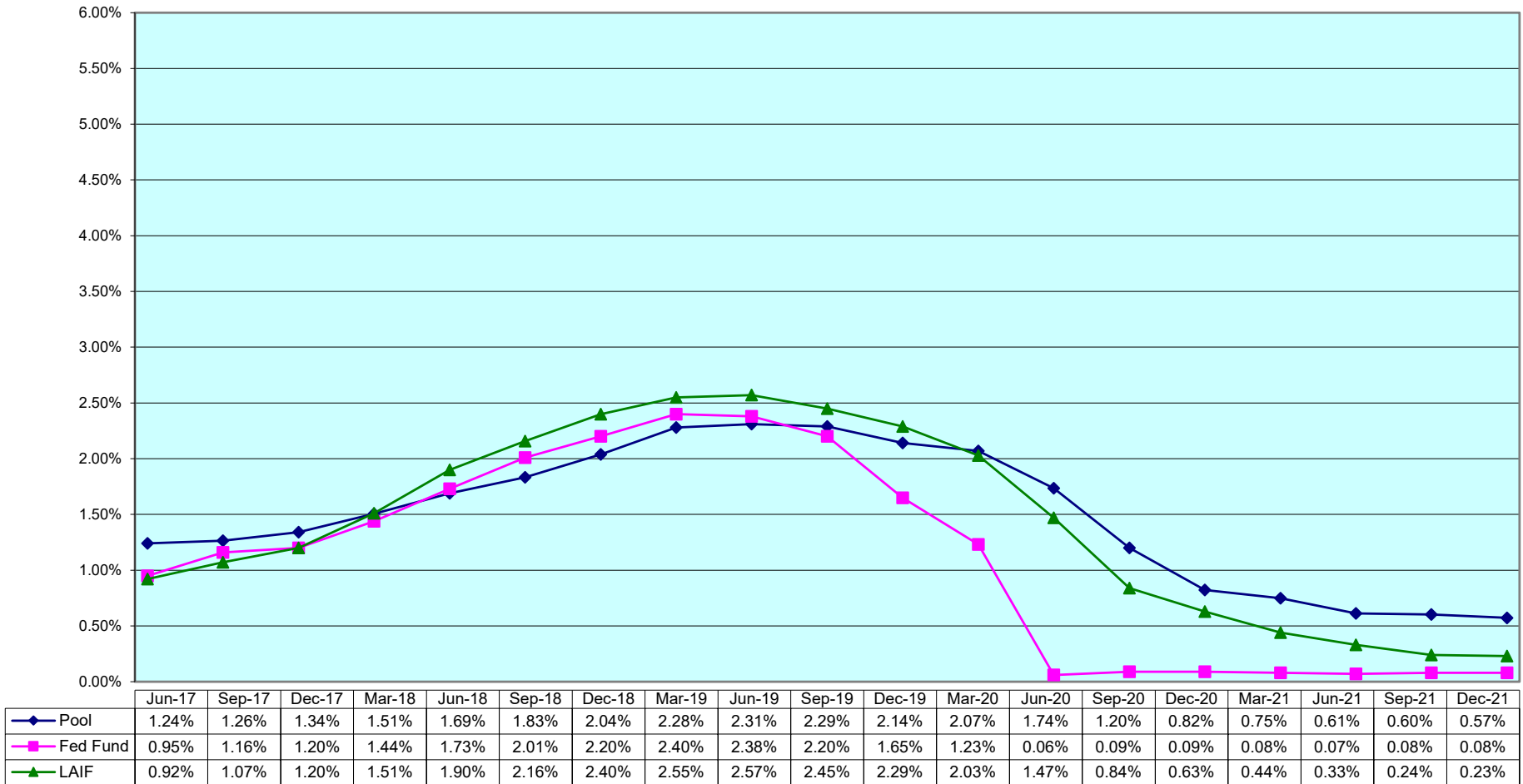
