### **Summary of Position Changes**

### **Recommended Budget Change Overview**

Exhibit D of the Budget Resolution (Tab 10) includes a detailed listing of Position Allocation changes. This memo provides an overview of them.

The Recommended Budget included a reduction of a total of 41 FTEs. Of these position eliminations, 7.5 currently may result in a layoff. The CAO is recommending retaining 3.5 of these through Program Change Requests (GSD-PCR-02, PROB-PCR-02) and Add Backs (PROB-AB-07). The other 4.0 are being recommended as position reductions. Two (2.0) of these positions are being eliminated due to lack of work and the other 2.0 are time-limited positions without an outside funding source. It is important to note that position vacancies evolve constantly, which affects whether or not a layoff actually occurs. As a result, one of the Recommended Actions in Budget Hearings is for the Board to Authorize Human Resources to implement strategies to mitigate layoffs to the extent possible.

#### 12-month Vacancy Sweeps

One of the Board adopted Financial Policies is to eliminate positions vacant for longer than 12 months. A total of approximately 80 FTEs have been vacant for more than 12 months. Of that total, 3.0 have been identified for deletion in the FY2021-22 Recommended Budget and 3.0 are recommended for deletion as a part of the Budget Hearing actions, and are reflected in Exhibit D of the Budget Resolution. The remaining positions are either in active recruitment or are being planned for recruitment during FY 2021-22.
