Please summarize but include additional information as necessary.</i></p> <p>These funds will be used to subsidize existing funding for Council on Aging's Senior Nutrition program (currently funded at 30% of the cost of the program), providing 8000 to 10000 meals per week to Older Adults through both home-delivered meals (Meals on Wheels) and drive-up 5 day meal pack sites throughout Sonoma County with the exception of Petaluma (served by PPSC). The need for our Nutrition program has increased over 100% since the beginning of COVID-19 from approximately 4000 meals per week to the current 8000 to 10000. Now that older adults are aware of the program and receiving needed meals, we do not expect these numbers to drop when the crisis is over.</p> <p>This request is eligible under the CARES Act , Part III - Miscellaneous Provisions, Section 4222 Nutrition</p> |

Even with anticipated additional Emergency Meal funding, we expect that will only cover 43,000 of the extra 210,000 meals we are currently providing. In total we will receive funding to provide only 127,000 of the over 400,000 meals we are providing. Last year the Board of Supervisors recommended that our request for supplemental funding each year be budgeted because the need was there. Our fundraising goals will not be met because of event cancellations. We are working to secure contributions with alternate activities, but there is urgent need for subsidy this year |

## DESCRIPTION OF FUNDING REQUEST

**What will the funds be used for?**

Funds will be used to ensure continuation of senior housing and elder abuse services. This funding will ensure that our elders remain safe and housed. There could be no more crucial time to ensure that those most at risk, our seniors, are protected, than during this unprecedented crisis. The number of housing related **calls we receive has tripled** over the past 3 months. Seventy percent **(70%) of these calls are from seniors**. And this is a mere foreshadowing of the tsunami of seniors who will need our help once the courts fully reopen and eviction moratoriums are lifted. Meanwhile, on the elder abuse front, while incidences of abuse increase during crises, COVID has trapped seniors at home with their abusers. We need to ensure these seniors have full access to protective legal remedies.

I am happy to report that over the years our request to the board has been getting smaller and smaller. Two years ago, it was \$185,000, and last year it was \$85,000. This year we are only requesting \$45,000 to maintain these life-saving services.

We do not believe this program is eligible under the CARES act.

Please summarize but include additional information as necessary.</i></p> <p>Our request is eligible under the CARES Act. The funds will be used to support our Meals on Wheels program for our Sonoma County clients. Our program provides one made from scratch complete hot meal (entree, side green and fruit salads, bread or roll, milk, and dessert) and up to six fresh frozen meals (entree, whole fruit, and milk) weekly to the Timber Cove Community and three complete hot meals and up to four fresh frozen meals weekly to other Sonoma County clients. Since the stay at home order was put into effect, Sonoma County enrollment in the program has increased 360% and we are now delivering an average of 397 meals monthly to these clients. The average monthly total cost, including delivery, is \$7,800 per month or \$94,000 annually. The increase has been driven by our service area expansion to Timber Cove and its surrounding ranches. This area was not served by any agency and there was a significant need amongst their senior population. In addition to the current population served, we hope to expand further to include the Kashia Band of Pomo Indians at the Stewarts Point Rancheria. Stewarts Point is in our current service area but we have not historically served Kashia's elders. COVID-19 exposed the need but we are currently unable to provide services given the current funding we receive. If able, we will provide an additional 160 meals monthly to Kashia at an estimated cost of \$2,500 monthly or \$30,000 annually. The total cost of the program will be \$124,000 annually.</p> |

Coastal Seniors is the only organization in this very rural coastal area that provides a full range of services to our seniors and disabled adults including, but not limited to nutrition, transportation and outreach. Our service area stretches 50 miles from Stewarts Point in Sonoma County to Irish Beach in Mendocino County, and inland 20 miles to Annapolis. We hope to be able to permanently expand our service area to include Timber Cove and the surrounding ranches. Many of the roads traveled are unpaved and remote which significantly increases the amount of time and expense required to meet the needs of our senior population.

**How will this funding support the County’s mandated or discretionary services?**

The Multipurpose Senior Services Program (MSSP) program provides both social and health care management services to assist frail individuals aged 65 or older to remain in their own homes and communities. The Sonoma County Area Agency on Aging is the County's MSSP provider. Coastal Seniors' Meals on Wheels program supports the MSSP by providing nutrition and wellness checks to homebound seniors thereby enabling them to remain in their homes for a longer period of time.

**Which County Department provides these programs, and have you contacted them regarding this request?**

The Sonoma County Human Services Department/Area Agency on Aging provides these programs and they are aware that we are submitting this request.

**Why is funding from the County needed?**

Coastal Seniors currently receives \$6,850 from Sonoma County Human Services Department to support our Meals on Wheels program. This amount represents 5.5% of the estimated total expenditures we expect to incur due to the program growth and expansion. The remainder of the estimated expenditures, or \$117,150, will need to be paid for using matching funds which primarily come from program income of less than \$1,000 annually, fundraisers, donations and private grants if available. COVID-19 has made it impossible to hold many of our usual fundraisers. We are exploring ways to raise funds virtually and in-person with social distancing but we are concerned that we will not realize the same revenue as in years past with the required format changes. In addition, we anticipate that private donations will also be lower than usual due to the uncertain economy. Without additional grant funding it will be very difficult or impossible to continue to provide the services needed in our very remote and rural area.

Last fiscal year we used additional fundraising and foundation grants to cover a deficit of \$105,355 to provide our suite of senior programing, including case management, home delivered meals, congregate dining, adult day respite and transportation, that deficit was prior to the COVID19 pandemic. With the Shelter In Place impacting those who are 60 and older, we have seen a dramatic increase in need for meals (both delivered and picked up). We continue to use all volunteers to deliver meals, through our existing home delivered meals routes. We are also using our iRIDE transportation program to deliver meals, to keep up the demand for services. Since June, we again began driving seniors to medical appointments. In order to keep our clients and volunteers safe, we are asking our team to work longer hours, including the kitchen staff and our Case Management team. Case Management is the gateway for all seniors services, and we continue to see a growing demand for this services. The largest increase in cost has been in the supplies and food needed to deliver a hot meal 365 days a year to South County residents.</p> |
